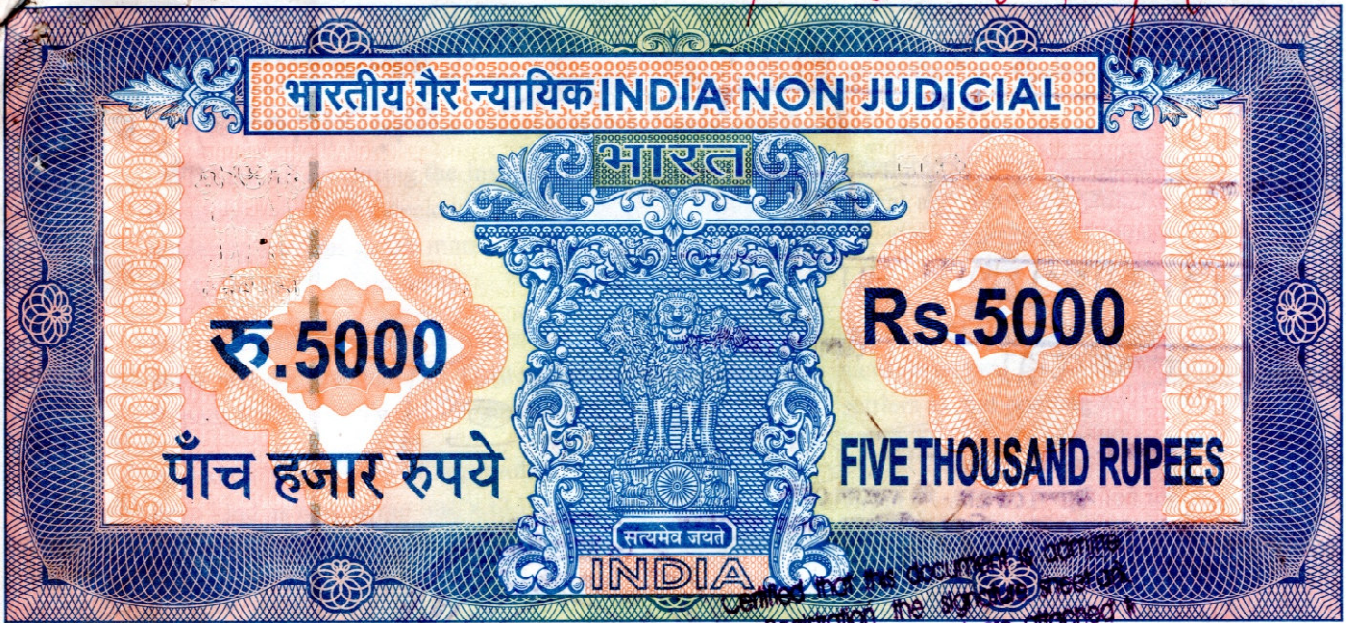

**WHEREAS** on getting the inspiration from the great services rendered by other institutions the aforesaid settlers decided to form a public spiritual, educational and charitable trust for rendering services to the mankind and to spread the sense of education, spirituality, Literacy etc. to the cause of humanity.

For effectuating the said desire of the settlers the trustees do and each of them does hereby agree and declare that (the Trustees) shall and will hold and stand possessed Rs.4,20,000/- (Rupees Four Lakh Twenty Thousand only) as deposited by the settlers as that opening fund.

And such further sum of accumulation, accretions, contributions and donation either in cash or in kind as may come into will be 'Trust Fund' or 'Trust Property' and to be applied for the attainment of the objectives of the trust and in accordance with the directions and provisions hereinafter specified.

**NOW THEREFORE THIS DEED WITNESSTH AS FOLLOWS:-**

1. The settlers have handed over the opening fund and the trustees have received and accepted the said amount of Rs.4,20,000/- (Rupees Four Lakh Twenty Thousand only) in the mode and manner started therein immediately prior to the execution of the deed , towards corpus of the Trust Fund subject to the directions and provisions as hereafter contained.

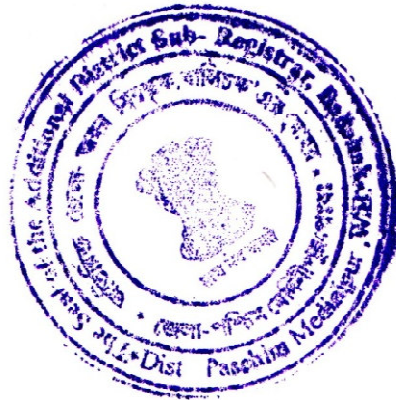
2. To give after to the above decision, the settlers have settled the amount of Rs.4, 20,000/- (Rupees Four Lakh Twenty Thousand only @ Rs.70000/- per settlers) into the trustees here of with directions and object as hereinafter contained. The above name trustees have agreed individually and collectively to act as trustees of the aforesaid amount and such future donations in cash or in kind and subscriptions as may be received from time to time by the trustees and all the income with all accumulations thereof and the addition and accretions there to and investment for the time being representing the same all of which shall hereafter be referred to as 'Trust Fund' or 'Trust Property' upon the trust and under the same hereinafter contained.

3. 4. The name of the trust shall be "GOURHARI DAS FOUNDATION" and the said name shall never be changed in future. The trust created by the present shall be irrecoverable.

5. The office of the trust for the time being shall be at C/O- Sri Madhusudan Das, Vill+P.O: Radhamohanpur, P.S: Debra, Dist: Paschim Medinipur, Pin: 721160 in west Bengal, bring principal office where all the books of accounts and the belonging to the trust along with the administration and management of the trust shall also be transacted, will the power given to the Trustees to shift the office to any other place in India upon the decision of the Board of Trustees. Besides this, branch offices and units may be opened at Kolkata or at any other place or places within India.

**I. OBJECTIVES OF THE TRUST:**

1. To establish, run and continue educational and vocational training institution including college in all disciplines, management, teachers training programme, Engineering (Degree, Diploma & ITI) college, Law colleges, Agriculture training institute, Pharmacy Education, Medical Nursing and also such other professional and academic course for the benefit of people at any place at any in India or abroad.
2. To establish, run and continue English or Bengali medium schools (Nursery to Standard-XII) under the affiliation and recognition of CBSE, ICSE and Other central, State Board.
3. To engage teachers, instructor, experts, other employees and agents etc. of good moral character and capable to impart efficiently and economically up- to-date instruction to student in modern sciences, industrial area, legal education, research work intellectual and other usual pursuits.
4. To establish, maintain in boarding house and residential accommodation for student and those connected with the Institution.
5. To develop healthy as well as critical attitudes towards development of mental, physical, moral ethical, spiritual, volitional aspects of the student /people of the society and those connected with the institution so as to make them good citizens.
6. To accept gift, donations grants, presentation and other offering and to deal with the same for the purpose of the trust.
7. To charge and to collect tuition fees and otherwise recoup the trust of the quality and expenses incurred for the upkeep and maintenance of institutions established and for about to the established under this deed.
8. To train and equip the pupil so as to become self-independence in an honourable and decent way of life which cause to develop and individual to be good, healthy and progressive citizen.
9. To develop discretionary conduct and a habit to observe the rules of law and self-restraint.
10. To bring out, encourage and develop the inventive and research facilities of the pupils and teachers and to provide opportunity for research work in art, science, humanity, technology and biochemical science and etc.

11. To publish newspaper, pamphlets, books, article, leaflets, booklets, and to organize public lectures, seminars, symposiums, discussions, debate etc.
12. To be affiliated and to establish connection with foundation and endowment in India or foreign countries in order to obtain financial assistance /donations to the Trust for carrying out its objectives for which the Trust is created.
13. To borrow loan from any nationalized sector i.e. Bank and /or institution and also from any authorized public sector by keeping mortgage any Trust property and deed of land and all the repayment will be done from the income of the institutions run by the trust.
14. In order to achieve the objective of the Trust the Trustees shall not undertake any such activities which is directly recognizing to religion, caste, colour, culture, sex or creed for such purpose.
15. To promote, maintain and devolve agriculture, horticulture etc. preserve animals and preserve food or vegetables and for such purposes purchase, take on lease or otherwise acquire lands, buildings, structures, and/or to contribute to any public trust or institutions established for any of the said purposes.
16. To launch project and programs on chemical free organic farming and Zero budget Agriculture, Eco-Initiative for protection of natural resources of Land, Soil, Water and Vegetation.
17. To create facilities for village farmer for managing their own units and get into marketing themselves and facilitate interfacing of production process with processing and marketing of agricultural product.
18. To preserve the environment and maintain ecological balance by water and soil conservation through Tree Plantation by launching a major initiative on 'Go Green' mission.
19. To work on Bio Gas Production, Generation of Electricity through Solar Energy, Water Shed Management, Recycling Water etc.
20. Establishment of research laboratories centres for researching out or utilization or conservation of water and its sources for betterment of agriculture and health in the country.
21. To establish support, acquire, maintain, run, Grant aid, give contribution and /or donations in cash /or in kind or otherwise to all manner of schools, college, universities, libraries, reading room, students hostel, lectures halls, museums, research institution, laboratories, music and culture institution, sports institutions including water dumb and otherwise handicapped and other establishment and for development of education and diffusion of knowledge.

24. To provide grant and give financial and other assistance to poor the deserving people, orphans, widows, the aged and physically handicapped the otherwise provide for their welfare and uplift.
  25. To establish, maintain, support, acquire, run and / or grant aid to institutions/ centre for the promotion, popularization, appreciation and development of science, literature and fine art which are conducive to the benefit of the public in general. To promote national integration by establishing place for social, cultural and spiritual congregation inter action and discourses.
  26. To render assistance in the form of financial loan or grant or other aids to recognized public educational trust, register societies or institutions.
  27. To arrange regular program in order to induce appropriate knowledge of technology ,mechanical, industrial ,engineering ,commercial and agricultural ,teaching education and other job oriented techniques, knowledge etc.
  28. To appoint as apprentices to any profession, trade, industry or institute for the training of persons of technical, mechanical, scientific, medical and others pursuits and make provisions for the their upkeep and maintenance into assist in obtaining employments.
  29. To establish, equip and maintain industrial, educational, homes for men as well as women for them all such arts, handicrafts and home industries including carpentry, designing, drawing, painting, photography, art work, carpet making, spinning and weaving laundry work dry cleaning, cooking, confectionery, knitting, sewing, embroidery, printing and other industries and skills.
  30. To arrange regular programme to make common people aware in general regarding pollution control, drug abuse, betterment of environment and to undertake programme to assist any organization for attachment of above subject.
  31. To provide for the advancement of other objective of general public utility real to the above and /or otherwise not involving the carrying on of any activity for the profit without distinction or improving the livestock which is beneficial to human beings.

**PROVIDED FURTHER**, that the objectives of the trust shall always be a consonance or in conformity with such objectives as would be considered charitable in under the law of the Country including the tax law applicable to the charitable Trust for the time being so that it may not lose its character to charitable nature as defined or laid down in any such law and in particular under the Indian income tax act and Indian Trust act as amended from time to time.

**II. PROHIBITION:**

1. That, none of the objective of the trust shall any time involve carrying of any activity for profit. The income assets and properties (both movable and immovable) of the trust whatever shall be applied for promotion of the objects of the trust.
2. That, the income of the assets of the trust fund shall not be applicable or transferred to any time in whole or in part for any purpose, other than education and welfare purpose, more fully described in the deed.
3. That, the income or assets of the trust shall not be applicable or used for the benefit of the authorities of the trust or any person who makes substantial contributions or donations of the trust or any trustees or manager of the trust.

**III. BOOKS OF ACCOUNTS AND ACCOUNTING YEAR:**

The trust shall cause true and accurate accounts to be kept of all money received and spent all the matters in respect thereof in course of management of trust properties or in relation to the carrying out the objectives and the purpose of the trust as well as of the assets and liabilities of the trust. The accounting year of the trust shall be 1st April to thirty first march of every year provided that first such shall be commencing month, year and on 31st March.

**IV. TRUST ADMINISTRATION, ROLE AND RESPONSIBILITIES:**

Trustee No.3, Smt Bandana Das Maity, Trustee shall hold the post Treasurer of the said Trust

**a) PRESIDENT:**

In addition to discharging normal duties of a trustee, the president will be authorized to sign all documents, including bank documents, acknowledgements for the contributions received, agreements with individuals, government institutions and other organizations on behalf of the Board of Trustees upon the decision of the Board for each and every case. Any document signed unilaterally by the President will stand null and void.

The President is authorized to sign along with the Secretary and Treasurer bank cheques, deposit release vouchers etc.

The President along with the Board of trustees is responsible for ensuring that the Trust pursues its objects and for maintaining the dignity of the Trust organization and shall use

**b) SECRETARY:**

The Secretary shall maintain the records of the organization prepare and circulate agenda and minutes of Board of Trustees meeting.

The Secretary shall be also responsible for the day to day administration activities of the Trust. The Secretary shall deal with correspondence received by the Trust, send replies in consultation with the President, and/or the Treasurer where necessary. He/she is responsible for the safe custody of all the assets and records of the Trust. The Secretary shall represent the Trust in all legal matters, sign the papers related to legal cases, attend to courts or represent the Trust in Government offices.

**c) TREASURER:**

The Treasurer will prepare Annual Budget, monthly and yearly expenditure statements get the expenditure audited by auditor duly appointed by the Board of Trustees and place them before the Board of Trustees for approval. The Treasurer is responsible to maintain cash book and prepare vouchers for the payments made, receive contributions, sign acknowledgements for the amounts or articles received by the Trust and prepare monthly and yearly statements of revenue and expenditure, as well as, the register of assets of the Trust and place them before the Board of Trustees for their approval.

The Treasurer is authorized to sign bank cheques, application for drafts and payment instructions jointly with the President and Secretary and draw money from the bank, up to the limits defined by the Board of Trustees in their meetings. The Treasurer is responsible for safe custody of cash, bonds, securities etc. of the Trust.

**V. POWER OF THE TRUST:**

For the furtherance of the objectives of the trust, the trustees shall have all necessary powers authorities as may be required for the administration and for the objectives and purpose of the trust and shall not be bound by any rules and regulations or laws as to investment or otherwise restricts their such absolute authority in so far as the same can be done lawfully be these presents and in so far as the same does not deprive the trust from availing exemption that may be granted of the trust for charitable purpose under the revenue and other laws, including the income tax act, which may be in force from time to time. Without prejudice to the generally of the foregoing, the trustees shall the have following specific powers and authorities.

1. The trustees shall be liberty at their absolute discrimination to accept any property, contribution collection donations from any person, firm or company or government or any other institutions for the advancement of the objectives of the trust.
2. Subject to the restrictions and directions contains in these presents to apply the whole or part of the income of the trust fund for any one or more of the objectives of the trust as the trustees may in their discretion from time to time determine and deem fit.

3. To convert and deal with the trust properties on such manner as the trustees may in their discretion think fit to achieve the objectives of the trust.
4. To investment and keep invested trust fund to movable or immovable properties in the trust securities authorities by the Indian trust act 1982 and income tax act 1961 as amended from time to time or in other securities or in deposit with or loan to any government, semi government authorities, bank and in home any of the trustees, founders, substantial contributors and /or his /their respective relative(s) do not have any substantial interest and defined in the tax act 1961 on such term as so security, interest and repayment as they may be their discretion think fit, for other of the same or of alike or different nature provided that the investments, loan and /or deposit shall be held either in the name of the Trust .
5. To borrow or raise secure payment of money on such term as to security ,repayment ,and interest as they may decide for the purpose of the advancement of the objective of the Trust.
6. To sell, disposes of alienate or otherwise deals with any property comprises the trust fund and keep and utilize the properties for the purpose of the trust but the said decision should be taken by all members of the trust.
7. To acquire or lease or purchase otherwise and /or construct any immovable property for utilization in achievement of any of the objectives of the trust and to let out and /or demise any immovable properties.
8. To join to co-operate this trust with other or other having considered or allied objectives upon such term and considered as the trustees may in their objective and nature of the trust.
9. To appoint, promote, demote, suspend or dismiss staff, officers or order employees for carrying out purpose of the trust and remuneration such person of the trust.
10. To enter into any contracts of furtherance of the objectives and other ancillary activities of the trust.
11. To undertake fund raising programme like inviting public donation, selling flags, emblems etc. cinemas and other culture shows fairs exhibitions and sports inviting appeal for advertisement in books, magazines and souvenirs publications of book etc. and utilized the properties for the public charitable purposes as aforesaid.
12. To carry and activity to the extent possible without affecting the registration of the Trust for the purpose of obtaining or continue exemption of the income of the trust from income tax and other taxes.
13. Without prejudice to the generally of the aforesaid the trustees shall have the power and authority to do all acts deeds and thing required for all as be conducive to the attainment of the objectives of the trust and or for in relation of the exercise of the power and authorities here in above contained.

15. That the trustees may reimburse themselves and pay and discharge out of the trust fund all expenses incurred by them in or about the executions of the trust or any of their duties under these presents including travelling expenses, but will not be entitled to any remuneration.
16. That the number of trustees shall be not less than four and not more than eight.
17. The trustee shall be entitled to apply for the acquire adequate plot of land from the government, semi government, or private party by way of deed of agreement, tenancy, lease, settlement, hire, donations and others in the name of the trust to run and manage the intended institutions by way of bank and private from any nationalized bank or any private institutions by way of bank or any individual bank if required to keep deposit of cash property, government securities shares, debentures, fixed deposit and other certificate as security, subject to the liabilities of income tax laws and rules are amended up to date.
18. The trust is entitled to for financial assistance in kind to term loan or working capital/od loan from nationalized/ private bank for infrastructure development working capital requirement and other development work of the trust subject to having valid resolution for the purpose and if that case either President, Secretary and Treasurer jointly will execute documentations and other formalities require to be complied for raising such loan or financial assistance and such executing power may be modified vide valid resolution.
19. Bank account in the name of trust may be opened at any nationalized /private bank to maintain savings/current, fixed /recurring deposits. And such accounts to be operated by the President, Secretary and Treasurer jointly and that can be modified vide valid resolution in the trustee board.
20. The trust may appoint managers, lawyers, solicitor, auditors, architecture, engineer, medical practitioner, surveyors, faculties and other employees for the purpose of management of the trust to run the institutions and supervision of trust properties, for collection of rents and profit for keeping the accounts and records and for other purposes of the trust.

#### VI. CESSATOIN AND DISQUALIFICATION OF MEMBERS AND TRUSTEES:

- (A) Following persons be disqualified from becoming members and trustees.
- (i) Persons of unsound mind.
  - (ii) Insolvents and bankrupts.

**VII. REMOVAL OF THE TRUSTEES:**

A leaving founder settler and the trustees for the time being by 2/3rd majority resolve that the continuance of any trustees is prejudicial to the interest of the trust after having given such effected of being heard considering his representation ,if any of the trustee about whom the resolution is adopted shall be deemed to have been removed.
